

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the www.easternoil.com and Eastern Oil Company and governs data collection and usage. Collection of your Personal Information

Eastern Oil may collect personally identifiable information, such as your name. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Eastern Oil. This information can include: your IP address, browser type, domain names, access times and referring website addresses.
